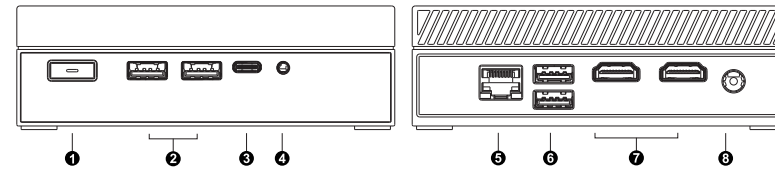

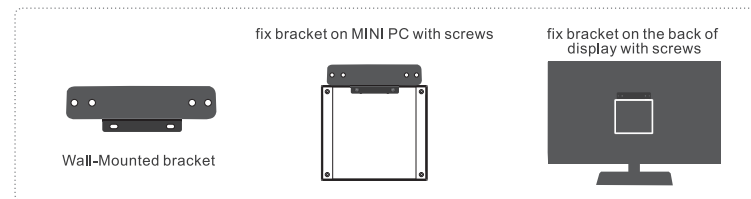

### 1. Basic Operation

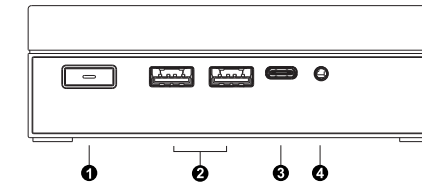


#### Button & Ports

| 4. Headphone microphone jack | 8. DC in port  |

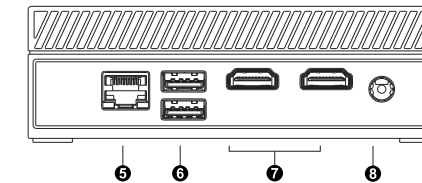


#### 1.1 Front view:
